Sub: Regarding change of College name in the 2 (F) and 12 (B) Certificate.

Sir/Madam,

We would like to request you to kindly change the name of our College from Government College Rhenock to Sikkim Government College, Rhenock in the 2 (F) and 12 (B) Certificates.

In this regard, we would like to mention that:

1. The College had applied for 2<sup>nd</sup> Cycle of NAAC Accreditation on 8<sup>th</sup> December, 2023. However, our IIQA was not accepted as the name of the College in the 2 (F) and 12 (B) Certificates does not match with the current name of the College.
2. The NAAC has asked for the clarification of the same by 29/12/2023 (*The screenshot of the Clarification raised by the NAAC is attached below*).
3. 2 (F) Certificate was issued on 25<sup>th</sup> March, 2009 and 12 (B) Certificate was issued on 29<sup>th</sup> November, 2020. The name of the College was then Government College Rhenock (*Copies of Certificate has been attached below*).
4. However, The name of the College has been changed by Government of Sikkim from Government College Rhenock to Sikkim Government College, Rhenock Vide Notification Ref. No. 18/DIR(HE)/HRDD date: 18/06/2021 (*Copy of Notification has been attached below*).

Therefore, we request you to kindly change the name of our College in 2 (F) and 12 (B) Certificates and issue new Certificates with rectified name for early acceptance of our IIQA for 2<sup>nd</sup> Cycle of NAAC Accreditation process.
